8. That the enrolment in each section shall not exceed the number of students calculated 10 sq.ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accomodation as per the norms of the Directorate of Education, Delhi in each class.
9. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately .
10. That the Govt. Nominees on the Managing Committee to be constituted as per the approved scheme will be asked for immediately .
11. The Managing Committee of the school shall not enhance the during the ensuing academic session without the prior approval of the Director of Education.
12. The Managing committee shall regulate the functioning of the school strictly in accordance with the provision of the Act and the ruels.
13. That all the facilities prescribedc under rule 50 & 51 of the D.S.E.R. 1973 shall be made available to the students.
14. That the arrangement of good drinking water shall be made available to all the students/teachers and sanitary facilities shall also be provided to the students.
15. Fresh Health certificate may be obtained from the M.C.D. within a month and be submitted to the Education oficer for verification.
16. That the Managing committee of the school shalol creat a reserve fund equivalent to three months salary or Rs. 1,00,000 lakh & Rs. 80/- per student whichever is less in a joint account in the name of the undersigned and the Manager of the school in a scheduled Bank within three months.

18. That copies of the appointment letter issued to the staff be provided for verification.



21. Provident fund register be maintained and cash book be completed and shown to education officer of the zone for verification from time to time.
22. That the violation of any instruction/ orders/ conditions/ rules and regulation of the Department shall lead to the withdrawal of recognition of the school and class XI shall not be opened without the prior approval of the Director of Education.
23. With reference to the correspondence resting with your letter No. SKPS/63/05 dated 25.04.05 on the subject noted above, I am directed to convey the approval of the Competent Authority for Upgradation of Sri Krishna Public Secondary School Paprawat Road, Roshanpura, Najafgarh, New Delhi - 110043 Secondary to Senior Secondary Level in Arts, Commerce & Science Streams (Physics, Chemistry, Biology) (without aid) w.e.f. Academic Session 2005 - 2006 and in Computer Science w.e.f. Academic Session 2006-07 (without aid) subject to the fulfillment of the following conditions:

1. That the school shall abide by the provision of Delhi School Education Act, 1973 and Rules framed there under as well as the instructions issued from time to time by the Department.
2. That the school shall admit the students without any discrimination of cast and creed as per the norms of the Department.
3. That the school shall appoint full time qualified and eligible staff as per the norms of the Department.
4. That a proper library shall be maintained and facilities for reading room shall also be made available for student as well as teacher. Books as per the ratio of ten books per student may be maintained and facilities of reading room may also be provided immediately.
5. Adequate stock of sports material shall be maintained and made available to the students with immediate effect.
6. That the school shall strictly abide by the provision of Delhi School Education Act & Rule 1973 and payment of salary will be made as per section, 10 (1) of Delhi School Education Act, 1973 to all employees. The salary should be paid by crossed cheque.


8. That the school shall dispense with the services of unqualified and over aged staff if any, immediately and compliance be sent within one month.

The Managing Committee of the school shall not enhance the fee during 2005 -2006 and subsequently academic session without and prior approval of the Director of Education, that is a mandatory requirement under sub – section (3) of section 17 of Delhi School Education Act, 1973, and other instruction on the subject.

15. Fresh Health Certificate may be obtained from MCD within a month and be submitted to the Education Officer concerned for verification.
16. The staff should be paid full salary through cross cheque.
17. That the management of school shall create a reserve fund equivalent to the three months salary or Rs. 2 Lac + Rs. 80 per student whichever is less in a joint account in the name of the Dy. Director of Education and manager of the school in any scheduled bank within three months.
18. Proof to the effect that staff has been appointed as per recruitment rules be provided to the Education Officer for his verification.




